The following policy decisions, taken in the 3rd session of the meeting, regarding empowerment of the District & Sessions Judges in certain administrative matters, duly approved, are conveyed for compliance in letter and spirit:

Autonomy to the District & Sessions Judge to decide;

- Court timings
- In-district transfer and posting of Judicial Officers, including Additional District & Sessions Judges (subject to prior approval of the PHC).
- Casual/short leave granting powers are delegated to the District & Sessions Judges for all Judicial Officers.
- Initiation of PER of Additional District & Sessions Judges as first reporting officer.
- Strict compliance with prescribed dress code by all.
