**NOTIFICATION**

Dated Peshawar the 24<sup>th</sup> March 2020

Pursuant to the Notification bearing No.SO(Estt)RR&SD/3-5/2019, dated 23<sup>rd</sup> March, 2020 of the Provincial Government, Hon'ble the Chief Justice is pleased to order that this Court, its benches and all the Courts throughout Khyber Pakhtunkhwa shall remain close w.e.f 24-March-2020 till 28-March-2020, however the following arrangements have been made in the public interest: -

- a) At the Principal Seat 02 Single Benches shall deal with civil and criminal urgent matters. At the Circuit Benches one SB shall deal with civil and criminal urgent matters.
- b) In each District 01 Court at Sessions Level and 01 Civil Judge cum Judicial Magistrate on rotation shall deal with civil and criminal urgent matters during the period.
- c) Staff aged 50 years and above, diabetic, cardiac patients and female shall avail vacations till further orders.
- d) There shall be essential staff at the High Court, its benches and District Judiciary i.e. one official per wing/office.
- e) 05 Days salary of the Hon'ble Judges of this Court, Judicial Officers and Officers (BPS-17 and above) throughout Khyber Pakhtunkhwa, besides 01-day salary of the Staff of this Court, its Benches and District Judiciary shall be donated to the Provincial Government Relief Fund/Department for its utilization in the relief effort carried out by the Government.
- f) This Notification shall remain effective in case the vacations are extended for the date and time prescribed therein by the Provincial Government.
