No. 147 -J, WHEREAS, vide order of the Competent Authority, disciplinary proceedings were initiated against **Mr. Irshad Ahmad Khan, District & Sessions Judge, Kohistan at Pattan** accused officer, under the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011.

AND WHEREAS, the accused officer was served with show cause notice and was also heard in person. After complying with the entire prescribed procedure under the Rules ibid, the Competent Authority has found that the charges enumerated in the show cause notice have been proved against the accused officer; and therefore, the competent authority has been pleased to impose major penalty of reduction from the post of District & Sessions Judge BPS-21 to the post of Additional District & Sessions Judge BPS-20 for two (02) years upon him.

NOW, THEREFORE, it is notified that major penalty of reduction from the post of District & Sessions Judge BPS-21 to Additional District & Sessions Judge BPS-20 for two (02) years is imposed on **Mr. Irshad Ahmad Khan, District & Sessions Judge, Kohistan at Pattan**, as enumerated in Rule 4 (1)(b)(i) of the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011, with immediate effect, provided that on restoration to original post, the accused/officer shall be placed below his erstwhile juniors promoted to higher post during subsistence of the period of penalty.
