1. Need analysis of the Security cameras for different sections of the building of the Peshawar High Court.
2. Need analysis of the multi-purpose managed network which is used for the data, voice and video and analysis of the existing network up-gradation to ensure transmission of data voice and video with cost.
3. Need analysis of power backup for uninterrupted working of security system.
4. Need analysis of the storage required for keeping the record of CCTV data.
5. Support in the assessment of selection process of company/firm for the project.

### Terms and conditions.

Firms/Companies will be shortlisted on the basis of following minimum eligibility criteria:-

#### a. Proof of registration

At least 05 years of incorporation/registration of the organization with relevant registration body. The firm/company shall be an active tax payer. The firm/company shall submit the valid registration certificate along-with the copy of National Tax Certificate and Income-tax clearance certificate for the last two years.

#### b. Complete Profile

Complete profile with list of clients and references relevant to the scope of this EOI.

#### c. Similar assignments completed

The firm/company shall provide completion certificate of at least 01 assignment.

#### d. Financial capacity/strength


At least 50 million turnover during each of the last three financial years as per auditor report supported by Bank Statement.

#### Human Resource & expertise

Profile of human resource/staff, relevant to the scope of this EOI, that would be specifically dedicated to this project.
